- 3. This application will not approve more than six passengers for hire.
- 4. Federal law requires that you must have a Captain's License (commonly called, a six pack license, to transport six or fewer passengers for hire.
- 5. Persons on Board-Other than Crew endorsment will be issued to you if this application is approved.
